Dear Mr. Simeroth and Mr. Curtis,  
Attached please find comments submitted by Energy Independence Now on the LCFS. Our comments, in summary, cover the following points:

1. The LCFS appears well designed to incentivize low-level blending of biofuels into conventional fuels, and spurring innovation to source and create lower carbon varieties of these blends. (We offer some thoughts for its fine tuning in that regard).
2. However, although the scope of the LCFS extends beyond biofuels, we are deeply concerned that the LCFS mechanism will not provide a sufficient incentive for the development of these other ultra-low carbon technologies. This could impair our ability to meet long term GHG goals, and effectively leaves all our eggs in one basket - biofuels.
3. We therefore urge ARB to assign dedicated resources and a stakeholder process to address the particular needs of non-biofuel technologies, with special attention to electricity and hydrogen given their low carbon promise. Our letter provides suggestions on some of the key issues to address as part of this.

### FIRST COMMENT

With reference to Draft Regulation Table 2, page 4

We recommend that Table 2 LCFS Compliance Schedule for Diesel Fuel, (and Table 1 on page 3 for Gasoline Fuel) be modified to require a smooth decrease in fuel Carbon Intensity.

We believe that the ANNUAL INCREASE in the amount of DECREASE in fuel Carbon Intensity on a fleet-wide basis is more likely to be a smooth curve rather than one that first jumps up and then back down three separate times (2011 to 2012, 2016 to 2017, and 2019 to 2020) as does the Compliance Schedule presented in Table 2. This point is especially clear when the proposed amount of ANNUAL INCREASE as shown in the Compliance Schedule is presented in chart form such as the one below.

No doubt it is good policy to start with small annual reductions as low carbon fuels are introduced and then increase the size of the annual reductions as low carbon fuels gain wider use. However, unless there is a policy driven reason to require only a tiny annual reduction of 0.5% in the "final year" of 2020, it seems to be a better fit with the natural world to start with small reductions and steadily increase the size of the annual reduction. After all, each annual reduction is a "per cent of the baseline CO2 emission" so there is no "per cent of a per cent" issue here. And, steadily increasing the annual reduction makes sense. As low carbon fuels gain market share you would expect that a 2.0% reduction in 2020 would become as easy to make as a 0.2% reduction in 2011. With growing use of low carbon fuel, it seems unlikely that any later year would have a smaller reduction than an earlier year. It is also unlikely that the reduction curve would reach a "flat top" (see 2018 and 2019 in the chart) in any year prior to the "final year". In fact, given steadily increasing use of low carbon fuels, it seems most likely that the largest annual reduction would occur in the "final year". Especially since 2020 is not really "a final year" at all, just a milestone on the way to 2050.

#### SECOND COMMENT

With reference to Table 3, page 12 of the Supporting Document:

LINE 3 Average Corn Ethanol CI = 68.2 LUC = 35 Total CI = 103.2

The bottom line of the table on page 6 of the 04/23/08 document specifies a TWW CI for denatured corn ethanol of 75.6 g/MJ (dry mill) and 89.0 g/MJ (wet mill). A non-weighted average of those two values is 82.3 g/MJ and the Total CI, using 35 g/MJ for LUC, would be 117.3 g/MJ.

What is the source for the new 68.2 g/MJ value for CI? Can you post the supporting calculation?

CAPCOA supports the goal of the Low Carbon Fuel Standard adopted by ARB to reduce the carbon intensity of transportation fuels. However, to ensure that local and regional air quality impacts are not exacerbated in the process and that energy reduction goals are actually realized, extensive analysis will be required prior to development of the implementing regulation, including the following:

1. Evaluation of the toxic and criteria pollutant impacts of biofuels to ensure that public health is not compromised in implementing this measure.
2. Analysis of the impact of biofuels on broader societal issues and how these might affect implementation effectiveness, such as the potential for the regulation to create "domino" effects on grains and crops that ultimately affect food availability and cost.

Dear LCFS staff,

Thank you for the opportunity to provide comments regarding the draft LCFS as it relates to hydrogen fuel. Please consider these informal comments - because of the diverse nature of the CaFCP membership, I am unable to gain overall consensus on formal comments. You may also hear from individual members directly.

1. I understand that based on proposed Section 95421(b)(1), providers of hydrogen would be exempt from the LCFS until total aggregate volume of hydrogen sold for transportation in California exceeds 420 million MJ (3.6 million gge) but that hydrogen providers could generate LCFS credits if they choose.
2. Several members agreed that it is appropriate to make the regulated party the owner of the fuel when it is dispensed. I did not receive any negative comments on this point.
3. The lookup table for hydrogen should not default to liquid H2 from natural gas as this cannot be the dominant pathway in California given existing law (SB1505). Instead, use a default pathway that yields SB1505-compliant hydrogen (30% reduction in CO2, 33% renewables etc.) This approach is similar to that used for electricity, for which the look up table value is based on California marginal mix in 2010 (Table 3, page 12 of Supporting Documentation).
4. I understand that providers of hydrogen can justify a lower carbon intensity value than what is included in the lookup table if they can support it for their specific pathway.
5. Using the Honda Clarity's USEPA certified fuel economy data to calculate the FCV EER of 3.0 is appropriate.
6. CARB's LCFS hypothetical compliance scenarios include FCVs ranging from 70,000 to 220,000 vehicles in the total fleet by 2020. These numbers are lower than other scenarios evaluated by the National Research Council[1] and the Oakridge National Laboratory[2]. Although the CaFCP members do not have a consensus recommendation for which numbers to use in a scenario that shows the possibility of ZEVs being more heavily weighted to FCVs, CARB could look to these studies for guidance. Keep in mind these studies clearly state that significant policy and financial incentives would be required to achieve a sustained, high-volume FCV market (also true for other alternative fuels.)
