How to use this table

1. Find motorcycle make and model year from the last two columns, or find desired aftermarket company in first column.
2. Find the corresponding EO from the second column
3. Click on the EO number shown as a [blue, underlined](#) link.
4. **Compare the engine family designation from the emission label on your motorcycle to the one listed in the viewed EO to ensure that there is a match. Also verify that the engine displacements match, as some displacements in the engine family may be excluded from the EO due to various emission-related factors. As such, do not rely solely on matching the motorcycle year and model.**
