## **EXECUTIVE ORDER G-03-005**

Relating to the Public Hearing for the Adoption and Amendments to Regulations for the State Ambient Air Quality Standards for Suspended Particulate Matter (PM) and Sulfates

WHEREAS, on June 20, 2002, the Air Resources Board (the Board or ARB) conducted a public hearing to consider adoption and amendments to regulations for the state ambient air quality standards for suspended particulate matter (PM) and sulfates, as set forth in the Initial Statement of Reasons and Staff Report released to the public on May 3, 2002;

WHEREAS, following the public hearing on June 20, 2002, the Board adopted Resolution 02-24, in which the Board approved amendments to sections 70100 and 70200; and adoption of new section 70100.1, title 17, California Code of Regulations (CCR), as set forth in Attachment A thereto, with the modifications set forth in Attachment B thereto;

WHEREAS, the Board in Resolution 02-24 directed the Executive Officer to adopt new section 70100.1 and amend sections 70100 and 70200, title 17, California Code of Regulations (CCR), and the modifications as described in Attachment B thereto, after making the modified regulatory language available for public comment for a period of 15 days; provided that the Executive Officer was directed to consider such writter comments as were submitted during this period, make such modifications as were appropriate in light of the comments received, and to present the regulations to the Board for further consideration if he determined that this was warranted;

WHEREAS, the Board approved modifications to the originally proposed text were made available for a 15-day comment period starting August 15, 2002, through August 30, 2002 in accordance with the provisions of section 44, title 1, CCR, with the modifications clearly indicated;

WHEREAS, written comments were received during the initial 15-day comment period, and those comments have been considered by the Executive Officer;

WHEREAS, in light of the written comments that were received during the initial 15-day comment period, additional modifications to the proposed amendments were made available by a Second Notice of Availability of Modified Text for a 15-day comment period starting October 10, 2002 through October 25, 2002, in accordance with the provisions of section 44, title 1, CCR, with the additional modifications clearly indicated;

WHEREAS, written comments were received during the second 15-day public comment period.

WHEREAS, all written comments received during the two 15-day public comment periods have been considered and responded to by the Executive Officer and the Executive Officer finds that no further substantive modifications are appropriate.

NOW, THEREFORE, IT IS ORDERED that the recitals and findings contained in Resolution 02-24 are incorporated by reference herein.

IT IS FURTHER ORDERED that sections 70100 and 70200, title 17, CCR, are amended and section 70100.1, title 17, CCR is adopted as set forth in Attachment 1 hereto.
