### NOTICE OF PUBLIC MEETING TO CONSIDER THE PROPOSED ALLOCATION OF \$25 MILLION FOR ALTERNATIVE FUEL INCENTIVES

The Air Resources Board (Board/ARB) will conduct a public meeting at the time and place noted below to present the multi-state agency recommendations to the Board for allocation of \$25 million for alternative fuel incentives.

This item will be considered at a two-day meeting of the Board, which will commence at 9:00 a.m., May 24, 2007. Please consult the agenda for the meeting, which will be available at least 10 days before May 24, 2007, to determine the order of agenda items.

Pursuant to the 2006 Budget Act (Assembly Bill (AB) 1811), the ARB is required to develop a joint plan with the California Energy Commission (CEC) to spend \$25 million to assist in the development of specific measures to reduce air pollution and greenhouse gas emissions through alternative fuel incentives. AB 1811 requires the funds to be encumbered by June 30, 2007, and fully expended by June 30, 2009.

There are a number of recent State policy directives that call for substantial expansion of the use and production of alternative fuels made from biomass and to reduce dependence on petroleum-based fuels. These include the Governor's Executive Order on biofuels (S-06-06), the Bioenergy Action Plan for California, and the Climate Action Plan. The ARB and CEC, with assistance from other State agencies, designed the Alternative Fuels Incentives Program to be consistent with the State policies on alternative fuels and the AB 1811 provisions.

ARB and CEC staff will present the multi-state agency recommendations for allocation of the \$25 million for the Alternative Fuel Incentives Program (AB 1811). ARB staff has prepared a summary with a brief description for each of the proposed projects. This

summary will be available at least 10 days before the Board meeting at the following ARB website:
