## AB 32 Cost of Implementation Fee Regulation

The Air Resources Board (ARB) invites you to participate in the 4th public workshop to discuss the proposed AB 32 Cost of Implementation Fee Regulation. This workshop is to discuss changes to the regulation that are being considered in response to the June 25, 2008 Board hearing and stakeholder input. The public comment period for proposed regulation has remained open.

Health and Safety Code Section 38597 (AB 32) authorizes ARB to adopt by regulation a schedule of fees to be paid by sources of greenhouse gas emissions (GHG) to support the administration costs of implementing AB 32.
