

EXAMPLE LETTER OF CREDIT

Updated September 18, 2014

This example letter of credit bid guarantee provides a standard format for California auction or reserve sale applicants and is meant as a guide only. Auction or reserve sale applicants will need to work with their financial institutions to ensure all the requirements are met, as described in Attachment A to the Auction Notice posted for each auction or reserve sale, prior to submitting any bid guarantee documents to the Financial Services Administrator.
