Purpose of Auction Consignment Wiring Instructions


- Federal Reserve Wire Network (or Fedwire) wiring instructions are required by the Financial Services Administrator to distribute auction proceeds from the sale of consigned allowances.
- Past procedures previously relied on postal service and email. Entering wiring instructions in CITSS provides an increased level of security.
- CITSS simplifies confirmation of existing wiring instructions prior to each auction.

November 2015 Joint Auction

- Beginning immediately with the November 2015 Joint Auction, Consignment Wiring instructions will be entered and confirmed in CITSS.
- Wiring instructions for the November 2015 Joint Auction need to be verified in CITSS no later than **Friday, October 30, 2015.**
- Wiring instructions provided by U.S. mail or email to the FSA for the November 2015 Joint Auction will not be accepted.
- The Financial Services Administrator will no longer request or accept confirmation of instructions by email.

Entering Wiring Instructions

- An account representative proposes wiring instructions. A second account representative verifies the proposed instructions. The FSA confirms the verified wiring instructions.
- After wiring instructions have been Confirmed by FSA, account representatives only need to confirm existing wiring instructions before future auctions.



Wiring Instructions Status History

- An entity's wiring instructions status is tracked over time in CITSS on the Wiring Instructions Detail page.
 - The Status History pane includes each action taken by account representatives and the Financial Services Administrator.
- Each time a account representative selects "Confirm" on the Wiring Instructions Detail page, the wiring instructions status will be set to Confirmed by Representative.

Wiring Instructions Statuses

CITSS provides account representatives with status updates throughout the process of entering, verifying, and confirming their wiring instructions, and Financial Services Administrator review.

- There are six potential wiring instructions statuses in CITSS:
 1. Incomplete
 2. Proposed
 3. Verified
 4. Confirmed by FSA
 5. Invalid
 6. Confirmed by Representative

Edit Durable Power Wiring Instructions

This page allows an account representative to edit wiring instructions. Enter the required information and select "Submit" to complete the action. The Beneficiary Bank ABA Routing Number must be 9 digits and cannot contain dashes or other special characters. Editing wiring instructions requires the following steps:

Step 1: An account representative enters and proposes the new wiring instructions.

Step 2: A second account representative verifies the proposed wiring instructions and CITSS forwards the verified wiring instructions to the Financial Services Administrator for confirmation.

Step 3: New wiring instructions become effective upon confirmation by the Financial Services Administrator.

Confirm for Future Auctions

- After wiring instructions have been confirmed by the FSA for the first time, those instructions can be used for the distribution of proceeds in subsequent auctions.
- Each time an account representative processes a consignment transfer to the Auction account, CITSS will prompt the representative to confirm the existing instructions.
- If the wiring instructions have not changed, an account representative must confirm the existing instructions in CITSS.

Are Wiring Instructions Correct?

Fedwire Wiring Instructions Confirmation

The wiring instructions for your account, shown below, are used to distribute proceeds from the sale of consigned allowances at an auction. If the wiring instructions are blank, they have not been entered or confirmed in CITSS. For security, the Beneficiary Account Number has been encrypted and only the last four digits are displayed. If wiring instructions are not accurate, they can be edited by selecting "Wiring Instructions" from the Limited Use Holding Account page.



Account representatives must confirm or update wiring instructions before each auction to which the entity consigns allowances. Account representatives must answer the above question using the dropdown menu. Selecting "Yes" indicates to the Financial Services Administrator that the existing wiring instructions are correct. If "No" or "I don't know" are selected, a reminder message to review the wiring instructions will be presented on the Limited Use Holding Account page. The reminder message is presented until existing wiring instructions are confirmed by an account representative or new wiring instructions are confirmed by the Financial Services Administrator.



Wiring Instructions Response

- When proposing or approving a consignment transfer, representatives must respond to:
“Are the wiring instructions above correct to receive auction proceeds that may result from the sale of consigned allowances?”
- Possible responses are “Yes”, “No”, or “I don’t know”.
- Entities that have not yet entered wiring instructions in CITSS should select “No” or “I don’t know”.
- Representatives should select “Yes” only if the existing wiring instructions are correct and have been previously Confirmed by the FSA.
