## AB 32: California Global Warming Solutions Act of 2006

### Public Meeting: Point of Regulation for the Sources of Fuel Combustion Included in the Second Compliance Period in a California Cap-and-Trade Program

**Topic and Purpose:** The California Air Resources Board (ARB) invites you to participate in a public meeting to discuss the point of regulation and the determination of regulated parties for the combustion of fuels that ARB plans to include in California's cap-and-trade program beginning in the second compliance period (2015-2018). This includes all fuels used by transportation, residential, and commercial sources as well as combustion at industrial sources with annual emissions of less than 25,000 metric tons carbon dioxide equivalent (MTCO<sub>2e</sub>).

In California, gasoline and diesel accounts for approximately 96% of direct emissions from transportation fuel combustion, while natural gas combustion accounts for approximately 88% of direct emissions from the residential and commercial sectors, with liquid petroleum gas an additional 9%. ARB's AB 32 Scoping Plan calls for fuels used by electricity generators and large (greater than 25,000 MTCO<sub>2e</sub>) industrial sources to be regulated at the start of the program in 2012, with the point of regulation in most cases being the point of emissions. This public meeting is the first in a series to discuss issues related to the introduction of additional fuel combustion sources to the program in the second compliance period. The meeting will also outline future topics of discussion for these fuels.
