## AB 32: California Global Warming Solutions Act of 2006

### Public Meeting to Discuss Linking California's Cap-and-Trade Program to Other Greenhouse Gas Trading Programs

**Topic and Purpose:** The Air Resources Board (ARB) will discuss linking California's planned cap-and-trade program with other greenhouse gas trading programs. Linkage can be the primary way by which states (and provinces) work together to create a regional program. Linkage with other programs would allow entities with a compliance obligation in California's program the flexibility to use allowances or credits from other programs to meet their compliance obligations. As such, linkage can serve a cost containment purpose. The cap-and-trade rulemaking will establish appropriate rules for using allowances and credits from other linked programs.

At this meeting, staff will summarize options for linking along with their possible implications. ARB staff will also seek your comments regarding programs to which California should link, and rules governing such linkages. As noted in the Scoping Plan, California is actively working with our partners in the Western Climate Initiative (WCI) to design a regional market that would be created through linking the individual partner programs. Options include potential links to programs such as the Clean Development Mechanism (CDM) and the European Union Emissions Trading Scheme (EU ETS).
