Stakeholder Comments

- Protocol amendments:
 - Intended to clarify existing requirements
 - Provide additional detail for implementation
 - Update data sources
- Stakeholder comments focused on three main areas:
 - Minimum Baseline/Logical Management Unit
 - Even-Aged Management Limits and Verification
 - Common Practice Values

Workshop Objectives

- On June 25, 2015 the Air Resources Board approved an updated version of the U.S. Forest Protocol
- Solicit stakeholder input for developing implementation guidance on:
 - How Common Practice values are used in setting the baseline
 - Logical Management Unit (LMU) definition
 - Even-aged management
 - Additional areas that may benefit from guidance

Guidance

- Describes and clarifies the regulatory requirements in a reader-friendly format
- Is not intended to and cannot establish new mandatory requirements beyond those that are already in the Capand-Trade Regulation (Regulation)
- Cannot supplant, replace or amend any of the legal requirements of the regulation
- Does not have the force of law

Regulatory Amendments

- Require a full regulatory development process
- Require Board approval
- Require review by the Office of Administrative Law
- Quantification Methodologies identified in the protocol require a public review and Board adoption to make changes because of CEQA requirements

Common Practice

- Used to help determine the baseline for Improved Forest Management Projects
- Values are based on the latest data from the Forest Inventory and Analysis (FIA) National Program
 - Discussed in detail in webinar October 14, 2014
 - Data available at: http://www.fia.fs.fed.us/tools-data/
- Values and high/low site class groupings have been adopted by the Board and cannot be changed through guidance

Common Practice Discussion

- Frequency of updates to Common Practice values
 - 5,7,10 year inventory cycles
 - FIA interaction
- Standards for adding new assessment areas
 - Minimum number of inventoried plots to determine common practice
 - Minimum number of years of data
- Are there implementation issues that require guidance?

Logical Management Unit

- The LMU defines the areas to consider for setting the baseline when initial carbon stocks are above Common Practice
- Defines the extent of forest owner's holdings that must be considered when developing the project baseline
- Protocol amendments:
 - Limits landholdings to project area's assessment area(s)
 - Identifies new criteria that may further limit the LMU
 - Area that has experienced natural disturbance
 - High Conservation Value Forest (HCVF)

Logical Management Unit Discussion

Proposed Guidance:

- Clarification of the definition of LMU
- Setting the LMU
- Assessing stocking levels within the LMU
- Verifying the LMU
- Other implementation issues for guidance

Even-Aged Management

- Defines limits on even-aged management activities and how to verify
- Values limiting the cut and buffer size have been adopted by the Board and are not subject to guidance:
 - 40 acre limit
 - Buffer size: 20 acre max/300 foot
 - 150 point count stocking level
- Consistent with the California Forest Practice Rules
 - ARB is not changing the California Forest Practice Rules

Even-Aged Management Discussion

Proposed Guidance:

- Guidance will be based on the California Forest Practice Rules, which was the basis for these amendments
- Clarify the definition of healthy trees for counting
- Verifying stocking and buffer requirements
- Other implementation issues for guidance
