SUBJECT: WORKSHOP ON CLIMATE CHANGE ALTERNATIVE COMPLIANCE STRATEGIES

The Air Resources Board (ARB or Board) invites you to participate in a public workshop to discuss alternative compliance strategies for complying with ARB's motor vehicle climate change regulations. During the workshop, staff will present background information, receive questions, and welcome public comment for the criteria that should be used to evaluate and approve alternative compliance strategies and how these strategies fit into the regulations ARB is developing to reduce climate change emissions from motor vehicles.

It is estimated that passenger vehicles and light-duty trucks are responsible for about 40 percent of the total climate change emissions in the state. The control and reduction of climate change emissions are critical to slow the effects of global warming, which is a matter of increasing concern for public health and the environment within the state.

Assembly Bill (AB) 1493 (Pavley, Chapter 200, Statutes of 2002) requires ARB to develop and adopt, by January 1, 2005, regulations that achieve the maximum feasible and cost-effective reduction of greenhouse gases emitted by light-duty vehicles. These regulations would apply to vehicles manufactured in the 2009 model year or later. The Board will consider the proposed regulations in the fall of 2004. Included in AB 1493 is a requirement to "provide flexibility, to the maximum extent feasible ... in the means by which a person subject to the regulations ... may comply with the regulations. That flexibility shall include, but is not limited to, authorization for a person to use alternative methods of compliance with the regulations." Staff welcomes input on the criteria that should be used to evaluate alternative compliance strategies and the guidelines for how these strategies work toward meeting a manufacturer's obligation under ARB's climate change regulations.
