**TOPIC: PUBLIC WORKGROUP MEETING TO DISCUSS THE DEVELOPMENT OF A REGULATION TO REDUCE EMISSIONS FROM UNDERINFLATED VEHICLE TIRES**

The Air Resources Board (ARB or Board) staff invites you to participate in a public workgroup meeting to discuss concepts for reducing the global warming impacts of underinflated vehicle tires. It is estimated that greater than 70% of all vehicles operate on at least one underinflated tire resulting in reduced gas mileage and increased emissions. Reducing Greenhouse Gas emission from underinflated tires is included as a discrete early action measure pursuant to the California Global Warming Solutions Act of 2006 (AB 32).
