## **Distributor Survey of Stationary Diesel-Fueled Equipment**

Dear Sir or Madam:

Enclosed please find a copy of the California Air Resources Board (ARB/Board) Stationary Diesel-Fueled Equipment Sales and Distribution Survey (survey). We ask that you complete and return the survey to the ARB by January 15, 2003.

The purpose of this survey is to collect current information on the sale of stationary diesel-fueled compression ignition equipment in California. Responses to this survey will provide the ARB with information that will help improve the emissions inventory for stationary diesel-fueled equipment.

For the purposes of this survey, a “stationary” piece of equipment is defined as:

A piece of equipment that is either:

- 1) is designed to remain in one location for the duration of its useful life, or
- 2) a unit that can be carried from one location to another but remains at a single location for more than 12 consecutive months.

Examples of stationary diesel-fueled equipment include, but are not limited to electric power generator sets, pumps dedicated for agricultural use, pumps not dedicated for agricultural use, welders, grinders, rock crushers, sand screeners, cranes, cement blowers, and air compressors.

Enclosed with this letter are the Survey Forms which you are asked to complete and return to the ARB. Also enclosed is the Survey Overview and Instructions booklet. This booklet provides background on the Survey and detailed instructions on how to complete the Survey.
