



*RULE 210 FEE ADJUSTMENT  
ANNUAL CHANGE IN THE  
CALIFORNIA CONSUMER PRICE INDEX*

July 1, 2006

In accordance with the provisions of Santa Barbara County Air Pollution Control District Rule 210.V.C., the Air Pollution Control Officer has performed an annual fee adjustment based on the California Consumer Price Index change of 4.2%. This change is applicable to fiscal year 2006/2007 and is effective July 1, 2006.

The attached table lists the Rule 210 fees that have been modified by the change in the Consumer Price Index. The revised fee schedules affect all fees not yet invoiced. Air Pollution Control District staff suggest that you insert the attached table into Rule 210 of your rulebook for ease of reference.

<sup>a</sup> The Rule 210 fees for fiscal year 2006/2007 shall be the "CPI-Adjusted Fee." Assuming there are no fee revisions, this fee will be used to calculate future CPI fee increases. For purposes of administrative convenience for fiscal year 2006/2007, the District will charge the "Fee Rate," which is the CPI-Adjusted Fee rounded down to the nearest cent or nearest dollar. The APCD revised the fees in accordance with Rule 210.V.C. These fees are effective July 1, 2006 and they are based on a California Consumer Price Index increase of 4.2 percent (April 2005 to April 2006). The APCD calculated the CPI-adjusted fee rates shown in the table by applying the 4.2 percent CPI increase to the fiscal year 2005/2006 CPI-adjusted fee rates and rounding the results down to four decimal places.

<sup>b</sup> The APCD rounded this fee down to the nearest dollar.
