**RULE 112 - CONTENTS OF PETITIONS**

*(Adopted 8/12/69, Revised 2/20/73, 3/9/76, 8/17/76, 11/21/78, 6/27/89)*

A. Every petition shall state:

1. The name, address and telephone number of the petitioner, or other person authorized to receive services of notices.
2. The name, address, and telephone number of the person who owns the emission source which is involved in the petition.
3. Whether the person who owns the emission source which is involved in the petition is an individual, co-partnership, corporation or other entity, and names and addresses of the partners if a co-partnership, names and addresses of the officers, if a corporation, and the names and addresses of the persons in control, if other entity.
4. The type of business or activity involved in the application and the street address at which it is conducted.
5. A brief description of the article, machine, equipment or other contrivance, if any, involved in the application.
6. The section or rule under which the petition is filed; that is, whether petitioner desires a hearing:
  - a. To determine whether a variance shall be issued, modified or revoked under Article 2, Chapter 4, Part 4, Division 26 of the Health and Safety Code;
  - b. To determine whether a modified compliance schedule shall be established or a variance issued for a rule not yet effective under Section 41703 of the Health and Safety Code;
  - c. To review the denial, suspension or conditional granting of a Permit under Rule 22 of these Rules;
  - d. To determine whether a Permit shall be revoked under Rule 28 of these Rules;
  - e. To determine whether an abatement order shall be issued under Section 42451 of the Health and Safety Code;
  - f. To review fees assessed by the District;

- g. To arbitrate any administrative conflict between the District and a permitted source;
  - h. To determine whether an emergency variance shall be issued for good cause, including, but not limited to, a breakdown condition as defined in Rule 32 of these Rules;
  - i. To review the decision of the District regarding approval or denial of emission banking under Rule 26.4 of these Rules;
  - j. To review the requirement to install a continuous monitoring system under Rule 103 of these Rules;
  - k. To rehear the decision of the Hearing Board under Section 40861 of the Health and Safety Code.
  - l. To review the disapproval of a trip reduction plan or a plan update under Rule 210 of these Rules.
- B. Each petition shall include a proposed order specifically setting forth all findings required by Rule 123, the facts to support those findings, and the relief desired from the Hearing Board.
- C. Each petition shall be signed by the petitioner, or by some person on his behalf, and where the person signing is not the petitioner it shall set forth his authority to sign.
- D. All petitions on other than standard petition forms shall be typewritten, double spaced, on one side of 8-1/2 inch by 11 inch paper, leaving a margin of at least one inch at the top, bottom and left side of each sheet.
