Dear Sir or Madam:

The staff of the California Air Resources Board (ARB) invites you to participate in a public meeting to discuss regulatory concepts for establishing fuel requirements for alternative diesel fuels (ADF), including biodiesel, renewable diesel and other emerging diesel fuel substitutes. Our goal is to conduct public meetings leading to the development of a regulatory proposal for consideration by the Board in Fall 2013. We anticipate the regulatory concepts would involve new alternative diesel fuel provisions, as well as amendments to the existing diesel fuel regulation to accommodate the new ADF requirements and to update outdated provisions. Please note that this effort will not involve changes to other existing transportation fuel programs, such as those for compressed natural gas, liquefied natural gas, liquefied petroleum gas, hydrogen, or electricity.

During this meeting, we will discuss our biodiesel literature search, completed and on-going emissions research studies, as well as preliminary regulatory concepts. ARB staff has posted a white paper, which describes staff's initial regulatory concepts for an ADF regulation. 
