The staff of the California Air Resources Board (ARB or Board) invites you to participate in the third public meeting to discuss draft regulatory language for the upcoming alternative diesel fuels (ADF) rulemaking. Staff intends to propose the ADF regulation for the Board's consideration at its November 2013 hearing. 
