The staff of the California Air Resources Board (ARB/Board) invites you to participate in a public meeting to discuss the ongoing development of a proposed Alternative Diesel Fuels (ADF) regulation. The ADF regulation was initially published on October 22, 2013. During the 45-day public review process, staff received comments and proposed alternatives to the noticed regulation leading to a notice of decision not to proceed on March 14, 2014. Staff will be preparing a new 45 day notice including an updated regulatory proposal, which will be presented before the Board in Summer 2014. At the workshop, staff will present proposed regulatory concepts and the next steps of the rulemaking process.
