The staff of the California Air Resources Board (ARB) invites you to participate in a public meeting to discuss the fuel comparison study of California diesel fuel and federal diesel fuels.

The Legislature enacted Assembly Bill 679 (Stats. 2006, ch. 11) requiring ARB to convene a panel of interested parties to develop a test protocol to measure the differences in oxides of nitrogen and particulate matter emissions between California diesel fuel and the U.S. Environmental Protection Agency's 2006 low sulfur highway diesel fuel. This meeting will be the fourth meeting of the Diesel Fuel Comparison Study Advisory Panel (Panel).
