The staff of the Air Resources Board (ARB) invites you to a public meeting on July 12, 2001 to discuss the ARB's regulatory and non-regulatory fuel activities for 2001. This will be the fourth meeting for this year's fuels regulatory agenda and non-regulatory activities. This amended workshop notice is to correct the items that will be discussed at this meeting.


