The staff of the Air Resources Board (ARB/Board) will hold a workshop to discuss ARB's regulatory and non-regulatory activities regarding Phase 3 California reformulated gasoline (CaRFG3) and E85 fuel specifications. This workshop will be the first meeting this year to discuss CaRFG3 and E85 activities.

The workshop will discuss issues pertaining to amendments being proposed to the CaRFG3 regulations. Staff will also initiate discussion on potential amendments for E85 fuel specifications.
