PROPOSED FISCAL YEAR 2015-16 FUNDING PLAN FOR LOW CARBON TRANSPORTATION INVESTMENTS AND THE AIR QUALITY IMPROVEMENT PROGRAM

School Buses in Rural School Districts: School buses in rural school districts may include fuel cell and battery electric zero-emission school buses, plug-in hybrid school buses with the ability to operate in zero-emission only mode in disadvantaged communities, and internal combustion school buses or hybrid school buses operating on renewable fuels, such as biodiesel, renewable diesel, or renewable natural gas. While any diesel powered school bus can operate on biodiesel, there are several manufacturers and conversion companies (Thomas and Bluebird) producing school buses that operate on natural gas, including renewable natural gas.

STAFF PROPOSAL FOR FY 2015-16 Due to the significant amount of early interest and the strong possibility that high quality project applications for the FY 2014-15 funding cycle will exceed the allotted \$25 million, staff proposes an additional \$65 million for FY 2015-16 for Zero-Emission Truck and Bus Pilot Commercial Deployments Projects, with \$45 million allocated to buses and \$20 million for trucks as shown in Table 21. Staff proposes separating bus and truck funding to better ensure that project applicants are competing against like projects, and to ensure that both technology markets are supported. Staff also proposes to set aside \$5 million from the bus allocation to provide incentives for school buses in rural school districts. Funding at this level is needed to increase vehicle production levels to the point where initial economies of scale can start to be realized. Staff anticipates strong fleet demand for this funding based on input received during the Funding Plan development process.

Jointly, CleanFleets.net & the California Compost Coalition (CCC) advise hundreds of heavy duty diesel truck fleet owners in the transportation and processing of organic materials (includes greenwaste, food waste, wood chips and municipal solid waste). Going into the 6/25/2015 CARB meeting, we are disappointed that natural gas vehicles have been excluded from consideration in the AQIP and GGRF clean truck funding plans. We have shared the following concerns with the CARB Board and staff since December 2014 and ask that financial incentives:

1. The recently released Short-Lived Climate Pollutant Reduction Strategy (SLCP) Concept Paper contains multiple references to enhanced organics management and natural gas transportation as key strategies of interest to ARB. CleanFleets and CCC share this interest toward 100 new or enhanced facilities (pp. 13, 20)
2. As recognized by the SLCP and Fuels and Sustainable Freight Strategy/Technology Assessment process, there are significant environmental benefits associated with the short-term widespread adoption of natural gas trucks (especially those operated on biogas (aka "renewable natural gas", or RNG) produced from organic waste
3. RNG fuel is the only fuel currently that can support "Carbon Negative" fleet operations
4. SB1204 (Lara) provides guidance that GGRF funds should be directed to existing technologies, for heavy duty trucks, that can positively impact environmental justice communities. RNG is the only fuel type that can do that in the near term.
5. The 2015-2016 Budget provides \$200 million for low carbon transportation. The Governor's Budget May Revision includes an additional \$150 million for low carbon transportation and this new opportunity for funding influences our larger coalition of Biogas/Calif NGV Coalition/Clean Energy to request additional discussion.
6. Our coalition convened a call on May 1, 2015 with MSCD Chief Erik White, ARB grants staff and the Calif Energy Commission (CEC) staff relating to RNG vehicle incentives from the GGRF. We were informed that battery electric and fuel cells are the priority
7. While we appreciate that CEC has a program, it does not stimulate the widespread near-term heavy duty RNG truck goals that our user group has. That's why GGRF funds are needed from CARB.

Dear Chairman Nichols:

The American Academy of Pediatrics, California, representing the 5,000 board-certified pediatrician members of all four California AAP regional chapters statewide, strongly supports the 2015-2016 Low Carbon Transportation Investments and the Air Quality Improvement Program Funding Plan that proposes \$5 million for school buses in California's rural and small school districts. This investment would facilitate the replacement of old school buses in small school districts educating and transporting students. A local education agency (LEA) with an average daily attendance ADA of 2501 or less.

Unlike many states, California does not require districts to take buses off the road after a set number of years. As a result, California has some of the oldest buses in the nation.

This disproportionately impacts students who have longer commutes and who have no alternative to get to and from school. According to the Air Resource Board, all bus-related exposures to fumes were due to the time spent commuting on the bus and not the time spent at bus stops or loading and unloading. This exposure causes asthma, which affects 6.3 million American school children and is the most common long-term childhood disease. Modern school buses also have improved safety features such as better seat belts and more emergency exits, making newer, cleaner buses an urgent priority.

Your staff proposal to support the next generation of environmentally friendly school buses is a reasonable and well-thought out measure to protect the health of California's children in a manner consistent with the goals of AB 32 (which AAP-CA supported) to reduce greenhouse gases and climate change.
