Aircraft Emissions arising from operations at Montgomery-Gibbs Executive Airport in San Diego (Zip 92123) are responsible for 1.4 metric tons of lead particle pollution released into the air each year according to the airport Master Plan.

We realize that AB 617 prioritizes disadvantaged communities. However, according to the World Health Organization there is no safe level of lead and children are the most at risk since lead exposure can cause serious damage to their developing brains, resulting in reduced intelligence quotient (IQ), reduced attention span, and increased antisocial behavior.

There are at least 6 schools within a mile radius from the airport. Therefore children attending those schools are exposed to lead pollution arising from airport operations the entire time they are in school. This is unconscionable, especially since the airport only sells leaded general aviation fuel when an unleaded fuel, approved by the FAA, that 80% of general aviation planes can use is available from Swift Fuels.

Because of these extenuating circumstances, members of the Montgomery-Gibbs Environmental Coalition respectfully request that the area around the airport be selected for the community emissions reduction programs as specified by the CARB Governing Board.

Our town council submitted a letter of support to the Association of Rural Town Councils, located in the Antelope Valley, to seek a small portion of the grant monies offered by CARB, through the Community Air Protection Program. We were dismayed and disappointed when the selection of worthy program areas did not include ours, especially since metrics evaluated met or exceeded those of communities that were chosen. Antelope Valley's residents experience the worst health outcomes for cardiopulmonary and respiratory illnesses, and childhood asthma across Los Angeles County. Moreover, Antelope Valley residents are nine times more likely than other county residents to contract Valley Fever--whose fungal spores are carried on fugitive dust.

It is crucially important to be able to assess particulates in our air, since there is no evidence that our area even complies with state or federal air quality standards for PM 2.5. We have one air quality monitoring station for 2,200 square miles. To address this problem, we need more monitors to actually classify air quality, locate the areas worst affected, and apply solutions to reduce particulates there, and ultimately, across the whole of our Antelope Valley Community.

We seek your assistance in learning how grant proposals are evaluated and what information we can provide that was perhaps overlooked, so we can ultimately help our valley provide healthier places to live, work, and play.

To whom it may concern,

The Littlerock Town Council supports the ARTC's and AVAQMD's air monitoring proposal under the CAPP program.

Since 2014, it has been noted by the Los Angeles County Health Department that the community of the Antelope Valley has the highest account of COPD, child asthma, and other breathing related conditions. We know that there are several industries in our region that create dust across the entire valley and so this is a condition that we all share. When we looked into who was monitoring our air we found out from the AVAQMD that there was only one system that was being used and that it was located in the middle of the City of Lancaster which does not equally represent the conditions that are found in the outlining desert community.

The townships of Littlerock, Sun Village, Pearblossom, Llano, and Lake Los Angeles all reside within the Antelope Valley Community and reside down wind of several industrial rock quarries. The dust that they produce has been a very big concern for us.

The ARTC's and AVAQMD's air monitoring proposal would provide sensors that could be placed in and around the areas where the heaviest activity might be suspected for a true and accurate account of the particulates in the air that we breathe. We ask that you reconsider. Please study the data of AB617 Community Selection Factors. I'm sure that you will note that the Antelope Valley Community scored much higher numbers in most of the selected factors than the 5 other communities who received grants.

It is of the upmost importance that we get to the bottom of our air quality issues, your support for our community needs would be highly valued.
