Subject: low cost community air quality monitoring

Comment:

We propose to collect data from on-board low cost automotive air quality sensors. The data will include CO/VOC, NO₂, PM₁, PM_{2.5}, PM₁₀, Temperature, humidity. The cost is \$90 per sensor + \$10 for installation. The results will be high-resolution air quality maps with a pitch of around 50 meters. We have done such pilots before and therefore have the right experience to minimize the likelihood of problems (published paper: <https://www.sae.org/publications/technical-papers/content/02-15-04-0024/>).

The sensors can be installed on any private car in less than 10 minutes. The data is then collected via a dedicated app installed on the owner's smartphone. We propose to equip 100 cars in the target community. It will identify pollution hotspots and pollution patterns during the day. The cost running the software and making the information available to the community members will be around \$2k per month. We would work on the project without compensation for our employees work. The total cost of the project would therefore be $\$100 \times 100 + 12 \times \$2k = \$34k$ for a one year campaign. We are available to present the proposal in more details.
