Overly regulated vehicles with restrictions on intake and exhaust not only slow the vehicles down they make them less fuel efficient. If less filial is burned less hydrocarbons are emitted into the atmosphere. Most of these vehicles are run on race fuel that is even cleaner burning and more efficient.
