Dear Chairman Sawyer and Members of the Board:

The California Strawberry Commission would like to express our support for amendment of the 1994 SIP for Ventura in Appendix H of your June 22, 2007, agenda item considering a statewide strategy for the 2007 California SIP. The California Strawberry Commission (CSC) represents all the 600+ growers, shippers, and processors of strawberries in California. California produces 88% of the fresh and frozen strawberry fruit in the USA with a current value of \$1.6 billion.

We would like to bring the following to your attention:

- Ventura achieved the 1-Hour Ozone Standard in 2002;
- Ventura County agriculture has significantly reduced emissions and adopted the best available control technology;
- the economic and environmental impacts if appendix H is not approved;
- amending the 1994 SIP is good for the economy and the environment;
- the 1994 SIP has been amended for Ventura in the past.

If Appendix H is not approved to transfer 1.9 tpd to the pesticide element of the 1994 SIP, DPR has reported that 10,000 acres will have to stop current production practices. According to the Ventura County Agricultural Commissioner's most current Annual Crop Report (2005), this would have an economic impact of \$286 million and we believe a loss of as many as 20,000 jobs. Moreover, the resulting pressure to develop these lands would likely lead to more emissions.

Ventura achieved the 1-Hour Ozone Standard in 2002

As you know, Ventura satisfied the 1994 SIP and achieved compliance with the federal 1-Hour Ozone Standard in 2002. "Best Air on Record..." reads a December 10, 2004 press release by the Ventura County Air Pollution Control District, noting, "There were NO exceedances of the federal one-hour ozone standard and NO health

advisories" The release further states, "With no exceedances during 2004, two exceedances in 2003, and one exceedance in 2002, Ventura County has effectively attained the federal one-hour ozone standard."

Ventura County agriculture has reduced emissions and adopted BACT

When the 1994 SIP was approved, the most common fumigation technology resulted in 74% emissions. In 1996, the United States Department of Agriculture, Agriculture Research Service formed a partnership with the California Strawberry Commission to evaluate fumigant alternatives. For the next several years, the partnership conducted over 25 on-farm, large scale demonstration projects. These projects showed that drip technology could both reduce the amount of fumigant needed to be used, and that the drip technology also reduced the emissions from 74% down to 22%. In other words, compared to the standard technology used in 1994, the new drip technology is at least 80% cleaner.

Beginning in 1999 and continuing for several years, the Commission published multiple papers on drip technology and recommended its adoption. Over the next 8 years the strawberry industry overwhelmingly adopted this new method and over 95% of the strawberry acreage in Ventura now use the lowest emission methods identified by DPR for each fumigant applied.

Flawed science leads to a flawed judicial order

Despite the fact that Ventura has achieved the federal 1-hour ozone standard, and that Ventura agriculture has adopted BACT, there is a remnant in the 1994 SIP that will cause an economic hardship if Appendix H is not approved and will directly lead to changes in land use that will likely result in significant increases in VOC emissions compared to the current agricultural uses.

In *El Comité para el Bienestar de Earlmart v. Helliker*, the Judge ordered DPR to implement a regulation using 1991 as a base year. Because the Judge only considered information that was used to develop the 1994 SIP, the court did not receive information about the numerous scientific flaws in the 1990/91 base years. For example, in 2003, EPA sent a letter to ARB stating that Methyl Bromide is not a VOC. Simply subtracting Methyl Bromide from the Ventura inventory reduces total pesticide emission by nearly 50%, resulting in total pesticide emissions constituting less than 3.5% of Ventura's total ROG emissions.

The Economic Impact

Because the judge got it wrong, the DPR regulation will be about satisfying an obsolete process and have a minimal effect on improving air quality. More specifically, because the order is based on obsolete scientific findings, DPR has reported that the new regulation would cause 10,000 acres to stop production, kill 20,000 jobs and result in an economic loss of up to \$286 million; all to accomplish a 2% reduction in total VOC emissions in Ventura, for an air district that has already achieved the federal 1-hour ozone standard.

The Environmental Impact

DPR Director, Mary Ann Wamerdam recently stated, "Is California agriculture part of our air-quality problem or is it part of the solution? The shift to higher-value crops and more fumigant use, for example, is one side effect of a statewide real-estate boom. Farmers who lease their fields have a hard time competing with land speculators. And farmers who own land have good reason to cash out before the next commodity price downturn, drought, or flood pulls them into debt for years to come. With so much riding on every year's crop, it's little wonder that lenders and landowners require growers to fumigate their fields – whether they want to or not – to ensure profitability. We must recognize that every segment of our society has some value in the overall scheme of things. Grow crops or suburbs? It's a false choice for the environment to swap one source of smog for another that could be worse."

As published in the DPR Statement of Reasons for their proposed VOC regulation, if Appendix H is not approved 10,000 acres will be impacted. The loss of fumigation will mean that yield will drop by half and growers will face financial hardship for no good reason. Without profitable agricultural use, this land will ultimately be developed into uses that will undoubtedly result in increased VOC emissions.

#### Not a Precedent

The 1994 SIP was a plan. New data becomes available and plans change. Since 1994, we know that BACT has been applied, that the air district has achieved the 1-hour ozone standard, and that the old 1991 inventory is significantly exaggerated.

In past years, Ventura has had similar situations where the 1994 SIP has been amended to allow for a transfer of credits from one strategy to another strategy. For example, the adhesives rule originally adopted by the local Air Pollution Control District had to be amended and credit from other programs was transferred to satisfy the targets originally planned. Such amendments are allowed by the Clean Air Act, and not unusual. This is not backsliding on the SIP commitment. It is an adjustment to the plan.

Our Request: amending the 1994 SIP is good for the economy and the environment

Your staff recommendation, reflected in Appendix H, proposed to revise the 1994 Ozone SIP to substitute 1.0 tpd of ROG emission reductions from California's on-going motor vehicle program, for 1.0 tpd of ROG emission reductions committed to for pesticides in the 1994 Ozone SIP in Ventura County.

After Appendix H was published, DPR published its proposed VOC regulation and supporting documentation. DPR's VOC Emissions Adjustment Memo (Table 23) shows that after BACT is utilized by 100% of the growers on 100% of the acres, that there is still a 1.348 tpd shortfall. This analysis was based on data from 2004. Growth has occurred since then. When adjusted with published data for 2007 acreage, the shortfall is 1.869 tpd. In other words, since Appendix H was published, DPR has published new technical data demonstrating that the correct amount to be transferred is 1.9 tpd.

We request that you approve Appendix H with the corrected number of 1.9 tpd to be transfer from the motor vehicle program to the

pesticide element.

Thank you.

I speak to endorse Appendix H (August 13, 2007 revision) of the Ozone SIP.

All organic gasses react photochemically, however they do not react equally.

The relative reactivities of many VOCs have been determined rigorously by Carter's lab at UCRiverside providing the MIR scale as a benchmark.

Although differing background air conditions and meteorological dynamics affect actual ozone formation, we find similar rankings in our recent field and lab work, with perhaps even stronger differences among compounds.

Using a scale, we can strive to reduce ozone most cost effectively by reducing the more reactive VOCs where more feasible. [Also importantly, we can strive to ensure we avoid making ozone worse by reducing a low reactivity VOC in place of a smaller amount of a more reactive VOC.]

Although MeBr should certainly be handled carefully for health reasons, and its emissions minimized for stratospheric benefits, MeBr has such a very, very low reactivity that it would be reasonable to exclude it from regulation as a ground-level ozone precursor.

Under the MIR scale, 1 entire ton of MeBr released out of the soil produces only as much ozone as a mere 10 pounds of average VOC; it is 200 times less reactive.

Of the other 3 fumigants commonly used in Ventura, two have relatively mid-range MIRs, and the third, metam sodium (or potassium), can release a gas by-product, but it has a fairly low reactivity.

To quote the DPR News Release from November 15th 2006: "The number of pounds applied is not as significant as the chemicals that contribute to that total." The director was referring to less toxic pesticides moving us in the right direction, but I suggest less ozone-forming also points in the right direction. [...said Warmerdam. "Increased use of less toxic materials shows that we are moving in the right direction."]

Furthermore, ozone production is strongly dependent on nitrogen oxides, NO<sub>x</sub>, which must also continue to be reduced. This is especially true in air basins under conditions where NO<sub>x</sub> is the limiting reagent, and where natural background VOCs limit our ability to reduce total VOCs. The ARB emissions inventory for 2006 in Ventura lists 55 tons/day anthropogenic but 33 tons/day natural - nearly 40% of VOCs.

NO<sub>x</sub> reductions are definitely another area where agricultural activities can help improve ozone. For Ventura (according to the ARB emissions inventory), only 5 source categories rank greater than 'Farm Equipment'. And unlike VOCs, only a tiny amount of NO<sub>x</sub>, roughly 2% comes from natural sources. We can reduce it much further than VOCs, and I am certain the agricultural community can do their share.

Lastly, I wish to acknowledge my colleagues at UCDavis and our cooperators around the state.

Recent air monitoring in the Lebec area indicates that air quality here is now worse than it is in downtown Los Angeles. Arvin, to our north, has the worst air in the country. Our middle school is located next to I-5, and our high school within 1/2 mile. Our kids are subjected to pollution 9 months out of the year, every day. Tejon Ranch has air quality monitors and data which they refuse to share with the public. I smell dairy odors every night in Frazier Park- never before in my 35 years here!

Its time for ARB to come up with immediate solutions and responses to these issues, including:

- Demand that Tejon Ranch release its data to the public and post it live online.
- Come up with funding to move our schools to different locations.
- Get rid of the dairies, composting and sludge that create air quality and odor problems, and address them as a quality of life issue, order Kern County to stop approving ANY dairy permits.
- Put monitoring data from TXI and National Cement online and enforce the law on BOTH of these operations.

OUR smog is not of our doing, but that of the San Joaquin Valley, vehicles on I-5 and operations such as TXI in Lockwood Valley and National Cement in the Antelope Valley. We used to have the cleanest, clearest air in So. Calif. I expect you to put it back to that status with immediate action on all of the above, and fully apprise the public with current Tejon Ranch data, the re-installation of an air monitor in our region that is owned by the public, not developers and by enforcing on air quality violations at TXI and National Cement. Your response to our region having the worst air in the US has been abysmal and overly-optimistic, with faulty statistics.

JUDGE RULES KERN MEGA-DAIRY VIOLATED FEDERAL

CLEAN AIR ACT

Valley-Based Group Intends to Enforce Law Against Other Violators

SHAFTER, CALIFORNIA - Judge Oliver Wanger of the United States

District Court in Fresno

ruled yesterday that a Kern County mega-dairy violated the federal Clean Air Act when it built

the dairy without an air permit and required pollution controls.

"The entire valley can breathe easier with this decision," said

Tom Frantz of Shafter, a member

of the Association of Irrigated Residents (AIR), a Valley-based

group, which brought the case

against the dairy in 2005. "This is a significant step towards

better health in the San Joaquin

Valley because our lungs will no longer be forced to subsidize the

dairy industry." AIR members

reside in Kern, Tulare, and Stanislaus counties.

AIR member Teresa De Anda of Earlimart said, "This is a great

victory for clean air in the

Valley. This decision means that new dairies will have to reduce

their pollution."

Judge Wanger ruled that California's "State Implementation Plan" -

the plan and strategies the

state adopts to achieve healthy air in the Valley - required the

C&R Vanderham Dairy near

Shafter to get an "authority to construct" permit from the Air

District, to install the Best

Available Control Technology, and to purchase "offsets" or

"emission reduction credits." Judge

Wanger rejected arguments that California law provided exemptions

from such requirements.

Further proceedings will determine whether the dairy must cease

operations until compliance and

the amount of civil penalties, which cannot exceed \$32,500 per day

per violation.

"These are not 'Happy Cow' dairies," said Linda MacKay, a Kern

County resident from Lebec

and an AIR member. "These factories are huge operations that

maximize profits and emit

significant amounts of air pollution, which the Court has ruled

must be regulated just like any

other industry."

Decomposing dairy manure, livestock feed, and cows' digestive systems emit volatile organic compounds. Volatile organic compounds react with emissions from cars, trucks, and other combustion sources - called oxides of nitrogen - to form smog, also known as ozone. Ozone pollution damages lung tissue, exacerbates and causes asthma, reduces lung capacity, increases respiratory and cardiovascular hospital admissions, increases school and work absenteeism, damages crops, and recent research shows that short-term exposure to ozone kills. The Valley consistently violates the federal health based 8-hour and 1-hour ozone National Ambient Air Quality Standards. The American Lung Association ranks Bakersfield, Visalia, Fresno, and Merced as the 2nd, 3rd, 4th, and 6th most ozone-polluted metropolitan areas in the country. It also ranks the San Joaquin Valley counties of Kern, Tulare, Fresno, and Merced as the 2nd, 5th, 6th, and 8th most ozone-polluted counties in the United States, respectively. Over twenty new dairies and over forty expanding dairies in the Valley have applied for "authority to construct" permits from the San Joaquin Valley Unified Air Pollution Control District. The Air District has issued several permits without requiring offsets or emission reduction credits, relying on the same arguments that Judge Wanger rejected in his ruling. Offsets are an important anti-pollution strategy that allow for new development as long as those new pollution sources pay existing Valley businesses to voluntarily reduce pollution. Because the new pollution source must buy more pollution reductions than what it proposes to spew into the air, the entire transaction ensures that the Valley's air quality will improve while allowing for new businesses to locate here. "The Court's ruling shows that the Air District has looked the other way and left Valley residents to fend for themselves," said Tom Frantz, President of AIR. "Until we get real leadership at the Air District that is not in the back-pocket of the Dairy Industry, AIR will continue to enforce the law."
