We are the Sierra Nevada Alliance an organization that unites hundreds of individuals and conservation groups throughout the Sierra Nevada. We've been working to protect and restore the natural environment of the Sierra Nevada for future generations while promoting healthy and sustainable communities since 1993.

The Alliance remains interested and invested in the land use target for carbon emission reductions, even though this legislation remains largely inapplicable to rural regions, including most of the Sierra. Despite this exclusion we know the emission reduction target set for the State by CARB is likely to have trickle down effects to rural areas. Depending on future decisions tied to carbon sequestration valuation, and future follow-up legislation to SB 375, this target could have especially significant repercussions to the preservation of timberlands, hardwood forests and working landscapes.

Like many individuals, organizations and agencies throughout the State we support the redoubling of this target from 5 MMT to 11 to 14 MMT. We know 11 to 14 MMT is a realistically high target based on the analysis of Dr. Reid Ewing and Dr. Arthur Nelson. Setting a higher target for the land use sector will signal that land use sector is a top priority and that regions should aim high and take decisive action to reduce greenhouse gas emissions from new development.

A higher target must be coupled with a commitment to providing financial resources, technical assistance and other support to help regions, local governments, and transportation agencies achieve the target. A higher target will also signal to the state of California that land use should be a high priority for financial and technical assistance to meet the goals of AB 32. Conversely, a low target will send the signal that business-as-usual development should continue, and that land use is not a high priority for resources and support.

I not only question whether sufficient scientific information exists to support quantifying greenhouse gas (GHG) reductions from passenger vehicles at the proposed 5 MMT level, but I also know of no credible scientific evidence that would indicate that larger reductions are reasonably achievable or sustainable without causing dislocations and extreme economic hardships.

Governor Schwarzenegger recently signed Senate Bill 375, which sets out the process to determine the actual Regional Transportation-Related GHG Targets. That process needs to be given deference and allowed to work. It should not be preempted at this early stage by unilateral action by the Board!

As a former land use attorney and current environmental law scholar who studies local governments' role in reducing greenhouse gases, I support redoubling the land use target from 5 MMT to 11-14 MMT. I have seen the critical role that local transportation planning can play in addressing climate change as an environmental law fellow at UCLA School of Law; however, I write in my capacity as an individual rather than as a representative of the University or the Law School.

This higher target is critical to signal that this is a top priority. We cannot meet our needed transportation reduction without reducing VMT. California has the opportunity to create a model for the rest of the nation in this area. These emissions reductions will create significant co-benefits for each region by also reducing criteria pollutant emissions, saving money, making budgets more resilient to increased fuel prices, among other things. Recent scientific estimates show that targets must be even lower than initially proposed to avoid catastrophic climate change and significant changes must be made within the next decade. This achievable higher target is essential.

A higher target must be coupled with a commitment to providing financial resources, technical assistance and other support to help regions, local governments, and transportation agencies achieve the target. A higher target will also signal to the state of California that land use should be a high priority for financial and technical assistance to meet the goals of AB 32.
