Comment:

Nicholas pointed out that a well-functioning cap-and-trade system would include no limits of the use of offsets. GPI supports this position. Unfortunately, ARB is considering rules that require that 51% reduction of GHG comes from onsite, limiting the use of offsets under the cap and trade program. For CHP, this is a rule that drives facilities to consider only big capital investments they can make in the turbine, for example. It locks out CHP from inexpensive investments they could make to reduce GHG in other sectors and jurisdictions through offset projects. For this reason, GPI recommends that CHP be exempted from the 51% rule.

GPI asks that ARB consider not adopting a hard floor for the auction price of allowances. This only serves to lock in the cost of compliance for cap and trade for industry. With the declining cap, we suspect that the supply of allowances will be constrained, so the market will appropriately keep prices elevated. This in turn will cause facilities to mitigate GHG as part or all of their compliance under the cap. So if supply is restricted through the declining cap, there should be no need for a hard floor on the auction price of allowances.

Subject: Hard Ceiling for Auction Price Allowances

Comment:

GPI recommends that ARB consider the use of hard price ceiling. While some interesting options were noted for soft price ceilings, we are concerned that they will have limited effect. Can ARB carry a large enough reserve to ensure that auction prices do not escalate so high as to cause facilities to go out of business and how will this reserve be replenished? Over time the cost of offset projects is likely to escalate as the inexpensive projects have already been conducted. The use of future vintage allowances seems to be a temporary stop-gap measure, passing the problem into the next compliance period. A hard ceiling will give industry assurance that it understands the maximum cost of compliance and can make future plans accordingly. A sense of price certainty is critical for industry to manage its way through cap and trade and AB32.

Comment:

GPI thinks that the allowance reserve has merit, but only as a means of borrowing allowances. Not as a credible soft price ceiling. With this approach, covered entities could borrow against the reserve for offset projects in progress. This would ensure that the reserve is repopulated. It would also decouple the timing issues associated with performing an offset project and meeting a compliance obligation, so long as we end up at the same end point anyway. GPI does not think it is necessary to include interest payments associated with this borrowing; if that was done one would have to rectify carbon prices at the time of compliance versus the completion of offset project - more complicated than it needs to be. Other speakers at the workshop noted the advantage of short term borrowing for the reserve as well.
