Below is a suggestion regarding the CARB staff alluding to a future "phase-out" of CCS/EOR under LCFS.

Given that CCS with EOR in California (particularly CO<sub>2</sub> EOR) will yield a lifecycle oil carbon intensity far below any native or imported crudes, the very last barrel of crude refined/utilized in California should come from in-state CCS with EOR.

Any phase-out of CCS with EOR from LCFS should be based on actual crude demand/usage in California rather than forecasts subject to political and/or other influences.

Subject: Approach to quantify carbon intensity of mixed feedstock digesters

Comment:

To whom it may concern,

Regarding your request for comment on how to appropriately quantify the carbon intensity of a mixed feedstock digester, Bluesource has a proposal on how to achieve this. We believe the following approach is conservative, reduce risk of overestimating credits, avoid crediting ineligible feedstock, do not overburdening digester owner/operators with testing or metering requirements, and lower risk of credit invalidation. The approach is as follows;

Approach:

Assuming there is one feedstock that makes up the majority of the feedstock, and any other feedstocks fall into an eligible category under the LCFS

1. Calculate the CI of the main feedstock (>75% of total feedstock by mass) using conventional methods (i.e. using simplified calculator)
2. Perform biomethane potential (BMP) test on one or both feedstocks to determine the quantity of gas produced by each feedstock. Tests can be performed once or twice annually.
3. Assume the temporary carbon intensity for the secondary carbon intensity (i.e. 45 g/MJ for WWTP sludge, -150 g/MJ for dairy manure)
4. Apply for fuel pathway validation under a tier 2 pathway

Requiring a digester operator to meter volatile solids for each feedstock, fossil fuels for each feedstock's handling and processing is extraordinarily onerous. This would undoubtedly would deter facilities and individuals from developing digester projects, thus slowing California's progress towards reaching its 2030 GHG reductions targets.

Comment:

I am inquiring as to whether ARB will consider changing the number of states which can use default distances for grain receipts in CA-GREET 3.0 pathway submissions.

The 9 states which currently receive this allowance were determined based on an ANL study from 2003. Over the past 17 years, states like Kansas and North Dakota have made great strides in improving their farming practices and grain production. Kansas, in particular, is now the 6th largest corn producing state and the largest producer of grain sorghum. North Dakota is now using corn to diversify their crop rotations for healthier soil and improved yields and is easily in the top 10 producing states.

Ethanol producers in Kansas and North Dakota receive thousands of grain trucks every month. Non-Midwestern States have to track mileage and origination data on all their grain receipts whereas Midwestern States may need to track some origination data to ensure compliance but can largely use default data.

As we get into a more intense reporting and compliance atmosphere, ethanol producers in non-Midwestern States seem to face a more rigid regulatory hurdle than those grandfathered into "Midwestern States" status. I would ask that ARB update the definition of a "Midwestern States" to reflect more recent corn/grain production data so that ethanol production facilities in major production regions can be treated equally.
