In light of this I think the revised target should default to the Alternative in the Staff Report that included these assumptions so that, to quote the staff report:

"An alternative scenario developed as part of the 2017 Scoping Plan Update includes additional energy efficiency gains, additional ZEVs, and an increase in the RPS, among other measures, that result in electricity sector GHG emissions as low as 30 MMTCO2e."
