Dear Mr. Williams and the California Air Resources Board,

The Community Environmental Council (CEC) sits on the Steering Committee of Plug-in Central Coast, a group funded by the California Energy Commission to prepare Ventura, Santa Barbara, and San Luis Obispo Counties for electric vehicles. We've produced a ZEV Readiness Plans, helped install over 300 charging stations, and helped prepare 100's of governments, businesses, condo associations, and others for EVs. We produce the Santa Barbara Green Car Show, a large static show and Ride and Drive event with automaker support that attracts 35,000 attendees annually, and host the regional Drive Electric week and other community events. We are very in tune with all niches of the EV ecosystem, from the drivers to charging station companies to automakers.

CEC is very concerned that VW's \$800 million settlement will be allowed to be spent entirely by VW in a way that centralizes the investment, overwhelms smaller competitors, and doesn't allow for a diversity of innovative approaches. We request that at least 50% of the settlement funds go to 3rd party activities that will deliver statewide, regional, and local solutions for EV infrastructure development, marketing, and outreach. VW has stated they received almost 200 proposals from California, and there is surely a wide variety of excellent projects proposed for the solicitation.

As we saw with the EV Project and NRG settlement, large centralized programs can experience delays and leave stranded assets. \$800 million is a very large sum to invest. We support efforts to diversify expenditure of VW's funds and reduce the risk of a centralized approach by funding 3rd party statewide, regional, and local projects. Diversifying VW's settlement investments will spur the innovation and market competition needed to reach 1.5 million EVs on California's roads by 2025.

Dear Mr. Williams:

On behalf of the Los Angeles Area Chamber of Commerce, I would like to express our support for Los Angeles to receive one of Volkswagen's two Green City designations in this first funding round.

The lawsuit that brought forth the settlement with Volkswagen stemmed from air pollution, and no place in the nation has been hit harder from diesel pollution than Los Angeles. When you combine the disproportionate impact felt within our communities from air pollution with other CalEnviroScreen factors, LA County represents over half of the state's disadvantaged communities.

Not only does Los Angeles have significant air quality needs, but the City also represents a market opportunity for the future of transportation electrification and the next iteration of urban mobility. The investments made by Volkswagen with the first round of funding, potentially accumulating to over \$44 million as they do in currently-slated Sacramento, can make a tremendous difference to propelling the region in this direction.

We recognize CARB's concern about having this investment be "transformative" by choosing a location small enough for effective impact, and it is for this reason that LA submitted a proposal that would concentrate investment within specific LA communities that need it most: Downtown, South LA, Boyle Heights, Wilmington, Pacoima, and LAX. By focusing on specific areas within a large city, the investment can achieve such goals as: leveraging a large market with existing investment to achieve a smaller subarea impact in parts of the city that could be transformative for ZEV deployment and infrastructure.

While we appreciate the opportunity to be one of the five metro areas selected for infrastructure investment in the VW plan, we believe an investment in LA should be more significant than infrastructure alone and seek to reduce, in the long term, the fuel-related problems and inefficiencies that lead to calls for improved infrastructure. Selecting Los Angeles as one of the first Green Cities will enable VW to achieve maximum impact by leveraging hundreds of millions in public and private funding (more than any other single location in the state) and mitigating emissions in communities that need it the most through accelerated ZEV deployment and infrastructure buildout.

As Southern California's Commuter Rail system operating across five counties and serving those living in the worst air quality conditions and congestion in California, the Southern California Regional Rail Authority/MetroLink strongly recommends that ZEV projects funded by both the ZEV Investment Plans and the upcoming NOx Mitigation Trust projects include transit applications. After years of emissions beyond what was expected, the inclusion of transit in the mix is critical to gain lost ground, and such investments are obviously required to make "Green Cities" truly green, and to support non-auto modes and to clean up emissions in DAC communities that are typically on rail lines (e.g., 84% of MetroLink's customers access stations within DAC zip codes.) Transit will give greater "bang for the buck" than single occupancy vehicles. In this recommendation for transit, as well as the strong reconsideration of the first Green City (which we believe should be in Southern California with its high CES 3.0 scores and majority DAC communities) we affirm the statements of others in Southern California and around the state who testified on March 24, 2017.

We also have some questions about project eligibility, and request more clarity on how the process to advance projects works, both for the ZEV Investment Plan and the NOx Trust funds. We notice you postponed an all day workshop that had been scheduled for April 6, and we hope you will answer these questions in the rescheduled workshop.

It does appear that the language from ARB allows off-road investments, but transit is not specifically called out. We believe this is a serious oversight. Our project eligibility questions:

• Would replacement and/or expansion of rail car movers with electric RCMS in yards be fundable under Appendix C or D?

Would electric multiple units (EMUs) be an eligible project? These would allow schedule flexibility with zero emissions and at lower cost, along busy corridors, luring more people out of cars onto transit.

Would a locomotive test bed using electric-diesel hybrids or fuel cells be eligible under Appendix C or D?

When will we have the opportunity for public input on potential projects for the NOx Mitigation Trust? How would we propose a project?

I would urge/beg you to include stringent service level agreements, targets and fines as part of the agreement. Even if enforcing and reporting those will mean a little less infrastructure.

Currently, all non-Tesla fast chargers have a bad reputation in terms of availability especially the EVgo infrastructure that was part of the last settlement with Entergy. All of them regularly have some kind of problem (doesn't work, only partially works, behind a closed gate, only available for customers, located in a area that makes it likely to get ICE'd). So the perception is, you can't really count on them. Even if in reality they work most of the time, a bad experience once being stuck somewhere because of it, has a devastating effect on the confidence of folks using them
