**REQUEST TO INTERVENE WITH CAP-and-TRADE**

Governor Jerry Brown,

My name is Jessica Vega and I live in South Gate, CA.

I am writing because I am concerned about the cap-and-trade regulation, and the detrimental effect it will have on California's economy and overburdened communities. I am a supporter of AB 32 because if implemented responsibly, it will help California reduce its greenhouse gas emissions and jump start a new green economy. I ask you to please intervene with the California Air Resources Board now and encourage them to replace the cap-and-trade program with regulations that include all industrial and agricultural sources of emissions. Cap-and-trade has been a failure in Europe and other areas - failing to reduce greenhouse gas emissions and resulting in fraud and other problems. I am very concerned that the cap-and-trade program will bring more pollution to already heavily polluted communities of color and delay pollution reduction in overburdened communities- we can't afford to forego reductions in the communities in most need of them. In addition, the cap-and-trade regulation squanders AB 32's potential to bring good paying, green jobs to local communities and push the green economy in California.

There are better alternatives to cap-and-trade that will reduce emissions while keeping jobs and economic development in California, just as AB 32 intended. I urge the Governor to intervene with the Air Resources Board and demand that they seriously review and adopt available and effective alternatives to cap-and-trade.
