The California Department of Transportation (Caltrans) appreciates the opportunity to comment on the Supplemental Staff Report on Actions to Further Reduce Diesel PM Emissions at Four high-priority railyards.

The proposed project in Los Angeles and San Bernardino Counties would improve the existing air quality environment surrounding four high-priority railyards at BNSF San Bernardino Railyard, BNSF Hobart Railyard, UP Commerce Railyard, and UP ICTF/Dolores Railyards. The project would also reduce health risks to residents of the surrounding communities from railyard emissions of diesel PM.
