Subject: Comments on Proposed Advanced Clean Fleets Regulations from Vernon Chamber

Dear Dr. Laskowski:

On behalf of the rendering industry community located in the city of Vernon, (Los Angeles County), Vernon Chamber of Commerce would like to provide comments on the proposed Advanced Clean Fleet (ACF) regulations. Vernon Chamber recognizes the substantial work CARB has accomplished in developing this proposal and appreciates the numerous opportunities offered for stakeholder involvement. The Chamber supports the improvement of the state's climate and air quality goals, especially the transition to cleaner vehicles.

The following comments from the Vernon Chamber are focused on the proposal's possible impact on the ongoing implementation of 1383. Significant air quality improvement is being achieved under 1383 by diverting organics from landfills, thus, reducing landfill gases, such as methane.

In CARB's most recent proposal, the importance of meeting 1383 landfill minimization goals is discussed as a reason for delaying implementation of the ACF regulation for waste and wastewater fleets that are involved in landfill diversion under 1383. The Chamber recognizes this approach but recommends to also include rendering operations to receive an extension, as they are essential to 1383 implementation.

The Chamber has been very involved with the City of Vernon in its efforts to bring waste haulers and businesses into compliance with 1383, including partnering on numerous educational forums. It is clear that the City of Vernon and numerous other cities rely on renderers in order to comply with 1383. CalRecyle recognizes rendering as a critical component to qualify as landfill diversion under 1383. On CalRecycle's website located at: <u>https://calrecycle.ca.gov/organics/slcp/faq/swf/#misc</u>, the fourth question under "Miscellaneous" specifies that rendering constitutes landfill diversion as required by 1383.

Many rendering trucks are already using alternative fuels, such as biodiesel and renewable diesel. Thus, it is consistent to include them in the delayed implementation being proposed for waste and wastewater vehicles.

Rendering provides many air quality benefits to the state of California. The rendering process is carbon negative. Rendering is the greenest option for recycling organics. Rendering of animal by-products sequesters at least five times as much greenhouse gas (GHG) emissions as it emits.

We recognize the importance of rolling out the Advanced Clean Fleet regulations and to continue the transition to cleaner fleets, especially within densely populated regions such as Southern California.

As rendering operations are doing the critical work of diverting organic waste from landfills, we urge CARB to allow the same implementation schedules for renderers as you have for waste haulers, as both are essential to the success of fulfilling the 1383 program.
