Dear Mr. Uhler:

The Clerk asked me to address your request to restore the hyperlinks in the text to your comment.

We reviewed your comment and determined that it poses an unacceptably high risk that a member of the public could click on a link and be directed to a malicious site. That assessment is based on: the high percentage of hyperlinks in your comment; the high number of hyperlinks from words that do not immediately display the entire hyperlink; and the links to certain sites such as twitter.com, youtu.be, and wwmpd.com.

I understand that in all likelihood, most or all of the hyperlinks used in your comment are safe. But for consistency, we decided to remove all the hyperlinks, and not to attempt to pick and choose among them.

In order to accommodate your request, however, we are willing to allow you to provide a one-page addendum to your comment, that lists in plain text all the hyperlinks that you wish to include in your comment. If you wish to do so, please send the one-page addendum as an attachment in a response to this email. We will add the addendum to your comment on our website.

You are also welcome to provide oral or written comments at the upcoming board hearing on this regulatory item. That hearing is tentatively scheduled for July 26 and 27, 2018. The specific agenda and confirmed dates will be posted to CARB's website.
