RE: Support for Volkswagen Settlement California ZEV Investment Plan

Dear Chair Nichols,

We are writing to express our support of the Volkswagen's Zero Emission Vehicle (ZEV) Investment Plan, including the designation of Sacramento as the first Green City with a proposed investment of \$44 million by June 2018. We believe that the City of Sacramento is a strong, capable partner that is ready to deliver on this important opportunity. The Placer County Air Pollution Control District has a history of working within the region to deliver ambitious projects and programs that benefit the region, including the establishment of ZEV fast charging along the Interstate 80 corridor to the Nevada State line, to complement the significant investment already occurring in the Sacramento region. This important effort will ensure that ZEV drivers in the Sacramento region now have access to the many amazing destinations offered in the Tahoe/Truckee region and beyond.

The staff of the Placer County Air Pollution Control District is ready to support with delivering transformational outcomes for the Sacramento region. We believe that Volkswagen's investment in Sacramento can provide a broad benefit that spurs innovation across the region. We support proposed investments in EV car sharing programs, ZEV delivery and taxi fleets, community charging infrastructure, and public education activities. These investments will serve as a critical foundation for complementary investments and programs in neighboring areas in Placer County, such as Roseville, Rocklin and Lincoln. Growth of these technologies into these areas is critical to the long-term success of the region's and the State's climate goals.

Sacramento is one of the most diverse communities in the nation, with significant potential to bring new ideas and service models to scale. Sacramento provides an ideal test market that is large enough to test new concepts, but small enough to implement visible change. Strong public-private partnerships provide a unique opportunity for the development of the ZEV industry, including new jobs-training programs and an emerging market for autonomous vehicle deployments. Sacramento's diverse neighborhoods also stand to benefit from new programs for clean and affordable transportation, including low-cost ZEV vehicles, public charging infrastructure, and new car share programs.
