

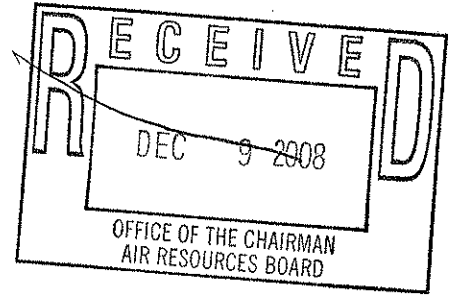

## Comments on Air Resources Board Proposed Scoping Plan

Dear Chair Nichols:

As a native Californian I wish to thank you and your exquisite staff for having developed a plan to solve a problem that has plagued our state for decades, population growth.

With the implementation of AB 32 as laid out in ARBs exceptionally thoughtful Scoping Plan the following apparent objectives should be substantially attained by 2020.

- 1) Expulsion of significant portions of the remaining value added California industry due to lower costs and lesser regulatory burdens in other states and nations. The obvious benefits of reduction of productive jobs and tax base will be to effectively reduce private and public sector employment, an excellent first step in population reduction.
- 2) Increase in tax rates and regulations reducing attractiveness of California as a home for people and business. With fewer productive jobs in state we can expect State and local governments to increase their taxation and regulation on those who remain, encouraging more to get the message we really do not want business or the people they hire here.
- 3) Energy and transportation costs in California will be substantially increased in relation to other parts of the world, reinforcing the message that California has a clear goal of reducing population. That should help discourage businesses and people for moving to California, and encourage some who are here now to depart.
- 4) Once we have established the trend of declining population we will have little need for the ability to construct new buildings or infrastructure. That benefits us by reducing the sustainable economic environment for tax paying companies, design professionals, material producers and vendors, skilled workers, laborers and others, further reducing the need or desire for people and assets for production to move to or remain here. When we do need those services, out of state and out of country firms will have a competitive advantage over firms foolish enough to be based in California, helping to keep people from wanting to live here permanently.
