# **Environmental Justice Working Group Opposes Scoping Plan**

### "Cut Greenhouse Gases, Don't Trade It"

### **Need Regulation, Not Pollution Trading**

"The Scoping Plan won't achieve emission goals mandated by the legislation because it relies heavily on a cap and trade program. Pollution trading programs in the U.S and Europe have been failures. In the Cap and Trade program called RECLAIM in Los Angeles and the European Union's version, both increased pollution and consumers paid higher prices for energy. Evidence shows that direct regulations have achieved the greatest reductions in emissions. This plan needs strengthening. As it is right now, it would be a disaster."

# **Need Substantial Greenhouse Gas Reduction in Goods Movement Industry**

"The Proposed Scoping Plan is the latest "little blue pill" offered up to the deal with the impotence of State leaders to effectively combat the deadly levels of pollution and greenhouse gases choking our families and destroying our communities," said Penny Newman, with the Center for Community Action and Environmental Justice. "While the movement of freight and transportation (trains, ships, off-road equipment and trucks) comprise the major sources of greenhouse gases in California (84% of the Nitrogen oxides and 50% of the VOCs), the plan offers no substantial reduction. With the proposed 3-5 fold increase in expansion of the Goods Movement Industry over the next few years it is impossible to achieve any meaningful results. The plan offers communities under the heaviest pollution burden nothing but a deadly shell game of promises, expectations, and data manipulation. We deserve and demand better."
