Dear Chairwoman Mary Nichols, Board Members and CARB Staff:

As president of Los Angeles City Planning Commission, I urge you to press forward with SB 375 implementation because it will set California back on the road to prosperity by promoting sustainable economic development and a more efficient and effective use of public resources. California is in the spotlight: Other cities across the U.S. and other countries around the globe are watching to learn from California's experience with reducing greenhouse gas emissions through AB 32 and SB 375.
