This work group meeting is a continuation of the April 16 meeting. CARB is seeking input from stakeholders regarding project modifications to HVIP and Low NOx Engine Incentives for the upcoming Fiscal Year (FY) 2018-19 Funding Plan for Clean Transportation Incentives.

HVIP and Low NOx Engine Incentives provide California fleets with vouchers toward the purchase or lease of a broad range of vehicle types and advanced technologies that achieve greenhouse gas reductions and air quality benefits, with an emphasis on providing benefits within disadvantaged communities. Eligible technologies currently include battery electric, fuel cell, hybrid vehicles, electric power take off systems (ePTO), and engines certified to an optional low NOx standard.
