SUBJECT: DIESEL EMISSION CONTROL SYSTEMS THAT COMPLY WITH THE
2007 NITROGEN DIOXIDE EMISSION LIMIT

The California Air Resources Board (ARB) amended the Verification Procedure, Warranty and In-Use Compliance Requirements for In-Use Strategies to Control Emissions from Diesel Engines in March of 2006. This amendment requires that verified diesel emission control systems (DECS) not increase nitrogen dioxide (NO₂) emissions by more than 30 percent of the baseline oxides of nitrogen emission level beginning January 1, 2007, and by no more than 20 percent beginning January 1, 2009.

The ARB finds the attached list of verified DECS to be compliant with the 2007 NO₂ emissions limit. Provided that all other requirements are met, the listed DECS will retain their verification status on January 1, 2007. Please note that the attached list may be updated at any time. The list of compliant DECS will be finalized as of December 31, 2006.
