SUBJECT: WORKSHOP TO DISCUSS UPDATES TO THE ZERO-EMISSION BUS  
REGULATIONS

The Air Resources Board (ARB or the Board) invites you to participate in a public workshop on May 20, 2009 in Diamond Bar, California and May 21, 2009 in Sacramento, California, to assess implementation of the Zero-Emission Bus (ZBus) purchasing requirements. During the last rulemaking the Board directed staff to review the technology and report to the Board on the status of the technology and the feasibility of implementing the purchase requirements as currently required.

At the workshop, staff will provide an update on the ZBus technology. Staff will also take comments on suggested program changes that would enhance successful commercialization of ZBus', and promote reductions in smog and green house gas emission from transit fleets. The ZBus regulation can be found in Title 13, Section 2023.1 – 2023.4 of the California Code of Regulations.
