The California Air Resources Board (ARB) invites you to attend a Compliance and Reporting training workshop (workshop) for the Heavy-Duty Vehicle Greenhouse Gas Emission Reduction Regulation (Tractor-Trailer GHG Regulation). The workshop will provide compliance training and an overview of the adopted Tractor-Trailer GHG Regulation including details on how to register using our online Truck Regulation Upload, Compliance, and Reporting System (TRUCRS), and information on how to meet the reporting requirements for 2011 and beyond. The TRUCRS reporting system is now available for fleets to upload their fleet information. ARB staff will also be available to answer questions about the regulation.
