SUBJECT: BOARD APPROVED 2011 CARL MOYER PROGRAM GUIDELINES

---

This mail-out presents the final 2011 Carl Moyer Memorial Air Quality Standards Attainment Program Guidelines (Guidelines). These Guidelines were recently approved by the Air Resources Board (ARB or the Board) at a public meeting in Sacramento, California, on April 28, 2011. The Guidelines became effective upon the Board's approval and are located on the following website:

In addition, staff has made four minor revisions to the Guidelines that were not included in Attachment B of the Resolution approved by the Board on April 28, 2011. These revisions have been made in order to correct inadvertent inconsistencies and typographical errors, and to reflect the language and policy approved by the Board.

Modifications to the Guidelines language are indicated by underlined text. Deletions to the language are indicated by ~~strikeout~~.

## Revision 1

Part I, Chapter 3, Section G.3.(A)

- (A) Initial Disbursement: An air district may request an initial disbursement ~~which~~ that includes all of its administrative funds and ~~a)~~ up to ten percent of its project funds, or ~~b)~~ \$200,000 of its project funds, whichever is greater. Minimum allocation air districts may request up to their entire allocation of \$200,000. An air district has the option to request additional project funds to be included in the initial disbursement if they can meet and demonstrate all the criteria described in Section G.3.(B).

## Revision 2

Page 21, Section C.8.(A)(8)
