SUBJECT: GRANT SOLICITATION TO ADMINISTER THE FISCAL YEAR 2012-13
CLEAN VEHICLE REBATE PROJECT

The California Air Resources Board (ARB or Board) is pleased to announce its grant solicitation for an administrator to implement the \$18 million Clean Vehicle Rebate Project (CVRP). CVRP was approved by the Board as part of Assembly Bill 118 Air Quality Improvement Program Funding Plan for Fiscal Year 2012-13 and provides rebates of up to \$2,500 for California purchasers of zero-emission and plug-in hybrid electric light-duty vehicles on a first-come, first-served basis.

Individuals, federal, state, or local government entities or agencies, and organizations or companies with expertise implementing a grant program and general knowledge of ARB's clean vehicle programs may apply via this solicitation to become the CVRP grantee. Applications are due to ARB by August 3, 2012. The grant solicitation and all associated documents may be found on ARB's webpage at <http://www.arb.ca.gov/msprog/aqip/solicitations.htm>.

ARB will hold an Applicant Workshop to answer questions regarding this grant solicitation on July 18, 2012.
