
The Air Resources Board (ARB) recently concluded an audit of the Eastern Kern Air Pollution Control District's (District) Carl Moyer Memorial Air Quality Standards Attainment Program (Carl Moyer Program). Enclosed is our Audit Report.

## Introduction

As part of the Air Resources Board's (ARB) ongoing review of the Carl Moyer Memorial Air Quality Standards Attainment Program (Carl Moyer Program or CMP), ARB staff audited the Eastern Kern Air Pollution Control District's (Eastern Kern APCD or District) implementation of the program. The audit began with an entrance interview on April 19, 2011, and was conducted in accordance with the "Audit Process for Rural Districts" in ARB's Audit Policies and Procedures. These procedures are viewable at ARB's website: <http://www.arb.ca.gov/msprog/moyer/audits/audits.htm>.

The audit reviewed program fundamentals, examined the use of public funds, and assessed whether emission reductions were real, quantifiable, enforceable, and surplus. ARB conducted the audit as part of its oversight responsibility specified in Health and Safety Code section 44291(d). A final exit conference where the results were discussed with the District was held on June 27, 2011.

### 1. Overall Assessment

The District's CMP is effectively administered, is achieving the expected emission reductions, and complies with State requirements. The audit resulted in no findings or recommendations. The audit team notes that the District has devoted significant resources in recent years to develop and implement their local CMP.

### 2. Scope of the Audit: Fiscal Years 2007-08 through 2008-09

The scope of the audit, fiscal years 2007-08 through 2008-09, covered two closed funding cycles. During these years, the District accepted more than the minimum allocation and agreed to provide match funding. Table 1 identifies project and administration funds the District received from CMP and identifies the required match funding.

### 3. Summary of District Projects Funded and Selected for File Review

Table 2 summarizes the number and categories of project types funded by the District over the scope of the audit. Funding sources included CMP, match, and earned interest funds. Project categories included off-road and agricultural sources.
