Pursuant to the authority vested in the undersigned by the Health and Safety Code Sections 39515 and 39516 and Executive Order G-45-9;

IT IS ORDERED AND RESOLVED: That the engine and exhaust emission control systems produced by the manufacturer for use in small off-road equipment are certified as described below:

BE IT FURTHER RESOLVED: That the Executive Officer has been provided all material required to demonstrate certification compliance with the Board's emission control system warranty regulations (Title 13, California Code of Regulations, Sections 2405 and 2406). The Executive Officer hereby approves these materials for use in complying with these sections for this engine family.

Engines certified under this Executive Order must conform to all applicable California emission regulations.
