SUBJECT: PUBLIC WORKSHOP TO DISCUSS UPDATED EMISSIONS  
INVENTORY FOR OFF-HIGHWAY RECREATIONAL VEHICLES

The California Air Resources Board (CARB) invites interested parties to participate in a public workshop on Wednesday, April 11, 2018, in El Monte, California, to discuss the updated emissions inventory for off-highway recreational vehicles (OHRV). The purpose of the workshop is to present CARB staff's updated estimates for current and future emissions from OHRV. Staff will discuss the key components and findings of their Red Sticker assessment, and explain how information on OHRV population, vehicle usage, and emissions rates have been incorporated into the latest update of the emission inventory. Proposed regulatory amendments for OHRV will not be presented at this workshop, but will be covered in detail by CARB staff in a separate workshop to be held later in April.
