SUBJECT: PUBLIC WORKSHOP TO DISCUSS PROPOSED REGULATORY LANGUAGE FOR A REGULATION FOR IN-USE ON-ROAD HEAVY-DUTY DIESEL-FUELED VEHICLES

The California Air Resources Board (CARB or Board) staff invites you to participate in a set of public workshops to discuss proposed regulatory language to reduce emissions from in-use on-road heavy-duty diesel-fueled vehicles. This regulation includes, but is not limited to: long and short haul truck-tractors, construction related trucks, agricultural trucks, wholesale and retail goods transport trucks, tanker trucks, package and household goods transport trucks, and any other diesel-powered trucks with a gross vehicle weight rating greater than 14,000 lbs. This regulation will not apply to heavy-duty vehicles covered by CARB's Solid Waste Collection Vehicles control measure or the On-Road Heavy-Duty Municipality and Utility Owned Truck control measure.
