Relating to Certification of New Motor Vehicle Engines

IT IS ORDERED AND RESOLVED: That the following International Harvester Company 1985 model-year diesel engines have shown compliance with the optional transient standards and are certified for use in motor vehicles with a manufacturer's gross vehicle weight rating greater than 8500 pounds:
